

“OFFICIAL RULES”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. This Sweepstakes is sponsored by O’Neill Vintners & Distillers, 8418 S. Lac Jac Ave. Parlier, CA 93648 (the "Sponsor").

1. **ELIGIBILITY.** Sweepstakes participation is open only to legal residents of the United States (except in Utah and where prohibited or restricted by law), 21 years of age or older at the time of entry. The “Line 39 BBQ Sweepstakes” (“Sweepstakes”) begins 12:01AM Pacific Standard Time (“PST”) on June 1, 2018 and ends 11:59PM PST on August 31, 2018 (“Entry Period”). Electronic entries must be received by 11:59PM PST on September 1, 2018. All entries become the property of Sponsor and will not be acknowledged or returned.

The following individuals are not eligible: employees, contractors, directors and officers of O’Neill and each of its respective parent, affiliates, subsidiaries and web-design, advertising and promotion agencies, fulfillment, judging or other agency involved in the administration, development, fulfillment and execution of this Sweeps (collectively, "Parties"), and the immediate family members (parent, spouse, sibling, child, and their respective spouses or "step" of each, regardless of where they reside) and those living in their same households whether or not related. ONLINE

I. FIRST REGISTER ONLINE: Limit of one (1) registration per person or email address per day. a) Complete and submit the online entry form found at: www.Line39BBQ.com (the “Website”). Entrant must complete all fields in the online entry form and check box agreeing to these official rules or entry will not be accepted. If you do not have a computer or other device to access the Internet, many public libraries offer free

access to computers and the Internet.

b) Or, you can enter the Sweepstakes by clicking on the Facebook icon and accepting the permissions of the Facebook app. If the app's permissions are not accepted, entrant will not have completed the process for a valid Entry. Entrant must complete all fields in the online entry form or entry will not be accepted. To use this method of entry, you must have a valid Facebook login and be a member of Facebook to enter using your Facebook Login; there is no fee to become a member. Your participation on Facebook must comply with the Terms and Conditions posted on www.Facebook.com/terms. You are providing your entry information to Sponsor and not to Facebook.

Entrant must confirm they are 21 years of age or older. Entrant must complete all fields in the online entry form or entry will not be accepted. Limit one entry per person or email address during the Entry Period. Entrants must have a mobile phone with text messaging and web browsing capabilities to enter and may incur a standard text message and/or data charge from their wireless service provider for each message sent and received. Check with your wireless service provider for details on these and other applicable charges. Entrants are solely responsible for any such wireless charges. Not all wireless carriers participate. Grand-Prize winners will receive a branded Weber Q1200 Portable Gas Grill (grill lid handle will be branded Line 39). Consumer will have a choice of color, 7 to choose from (black, red, titanium, blue, orange, green or purple). Approximate Retail Value (“ARV”) of total grand prize winners is \$1,575. Alcohol is not part of the prize.

No substitution or cash equivalent of prize is permitted except at Sponsor’s sole discretion. Winner is responsible for any and all federal, state and local taxes or assessments and any person winning over \$600.00 in prizes will receive an IRS Form W-2G from Sponsor for the calendar year in which the prize is awarded.
